SPORT AND RECREATION MANAGEMENT CERTIFICATE

Purpose

Vancouver Community College's Sport and Recreation Management Certificate focuses on providing industry experience and learning opportunities to develop the necessary skills, knowledge and abilities for success in the sport and recreation industry.

Students will gain comprehensive knowledge of sport and recreation in Canada including organizational structures, governance and career opportunities in local, provincial, national and international associations.

With relevant and industry-supported curriculum, graduates will be well prepared for positions in a variety of roles including sport or recreation manager, sport or recreation program leader, sport or recreation program coordinator, and sport or recreation event and marketing coordinator

Program values include leadership, diversity, community and industry partnerships, and personal and professional development.

Duration

The Sport and Recreation Certificate is made up of 30 credits. Students must successfully complete all courses in this program to be eligible for the certificate.

Students usually take 18 months to three years of part-time study to complete the Sport and Recreation Management Certificate. Maximum time allowable for completion is five years.

Learning Outcomes

Upon successful completion of this program, graduates will be able to:

- 1. Integrate principles and concepts of sport and recreation administration and leadership into employment roles and workplace relationships
- 2. Communicate effectively with internal and external stakeholders in the sport and recreation industry
- Apply tools of business administration, sales and marketing, human resource management, business ethics, and finance to issues and opportunities in sport and recreation management
- 4. Apply knowledge and skills of sport and recreation management to identify roles and opportunities available within the industry
- 5. Plan and coordinate activities related to public relations, programming, networking and event management within the sport and recreation industry
- 6. Use problem solving strategies to resolve issues and challenges that arise in the context of sport and recreation management
- 7. Adapt and respond to a variety of tasks and situations common in a sport and recreation management context

Admission Requirements

Applicants should be 18 years of age or older or a graduate of a secondary school.

To be successful in this program, we recommend a minimum of English 12 or equivalent.

Grade Point Average (GPA)

- 1. The course grade points shall be calculated as the product of the course credit value and the grade value.
